

PUBLIC OFFER

for the provision of services for converting a web resource into a ZIP archive

G.Krasnodar

1. General Provisions

1.1. This offer is a public offer (offer) by a self-employed person, Maxim Aleksandrovich Manshilin (hereinafter referred to as the "Contractor"), who applies the special tax regime "Tax on Professional Income" in his activities, to enter into a contract for the provision of services for the conversion of a web resource into a ZIP archive under the terms and conditions set out below with users (hereinafter referred to as the "Customer").

1.2 Terms and definitions

An offer is an invitation to enter into an agreement for the provision of services for the placement of advertising materials, located on the Internet via a link and containing all the key terms of this agreement.

Offer acceptance means the Customer's acceptance of the terms of the Offer. The Customer is deemed to have accepted the terms of the Offer by clicking the "Pay and Download" button on the Contractor's website.

The Contractor's website is located on the Internet at the following address:<https://web-zip.ru>

2. Subject of the agreement

2.1. The Contractor undertakes to provide the service of converting the web resource specified by the User into a ZIP archive, and the Customer undertakes to pay for this service.

3. Cost and payment procedure

3.1. The cost of the service is fixed and amounts to 5 (five) US dollars for one downloaded ZIP archive.

3.2. Payment is made by transferring funds to the Contractor's bank account before uploading the archive to the Contractor's server.

3.3. The cost of Services is not subject to VAT due to the application of the Professional Income Tax (PIT) by the Contractor.

4. Procedure for provision of services

4.1. To receive the service, the Customer must:

- Specify the URL of the web resource

- Confirm agreement with the terms of the offer
- Remit payment
- Download Zip archive

4.2. The service will be provided within 24 hours from the moment of payment.

5. Rights and obligations of the parties

5.1. The Contractor undertakes to:

- Provide the service within the specified time frame
- Provide a high-quality ZIP archive
- Ensure data privacy

5.2. The Customer undertakes to:

- Provide correct information about the web resource
- Pay for the service in full

6. Responsibilities of the parties

6.1. The parties shall be liable for failure to fulfill or improper fulfillment of obligations in accordance with the current legislation of the Russian Federation.

7. Limitation of liability of the Contractor

7.1. The Customer acknowledges and agrees that the service is provided "as is" and is intended solely for converting websites to which the Customer has legal rights into a ZIP archive.

7.2. The Customer undertakes to:

- Do not use the service to copy websites containing protected intellectual property without the permission of the copyright holder;
- compensate the Contractor for all losses, fines, legal costs and other expenses arising from claims by third parties due to the actions of the Customer.

7.3. The Contractor shall under no circumstances be liable for:

- violation by the Customer of the intellectual property rights of third parties;
- direct or indirect damage caused to the Customer or third parties as a result of such violation;
- blocking, removal of content, or other measures taken against the Customer or its resources at the request of copyright holders or government agencies.

7.4. The fact of using the service by the Customer means full acceptance of the terms of this clause.

8. Final Provisions

8.1. The Agreement shall enter into force upon acceptance of the offer and shall remain in effect until the parties fulfill their obligations.

8.2. All disputes shall be resolved in accordance with the legislation of the Russian Federation.
